Dear College Fund Supporters:

The men are going missing from American colleges, and we at the College Fund of Pinellas know it. With each passing year, it seems, fewer male students are applying to college. While College Fund applications are up, our male applications are noticeably down. In our newest class of recipients, for example, about 20 percent are male. It would be great if we could turn this trend around and simply say "Look at all the women finally getting a chance to take advantage of all the lifetime opportunities that higher education provides!" but the measurables point to some harsh trends unfolding among men even as women find opportunities.

Andrew Selepak, a social media professor at the University of Florida, wrote in an op-ed piece recently about several factors pushing young men away from college. Costs, sure, but they are roughly the same for both men and women. He also cited a very-respected survey that found more males simply did not want to go to college. Another sampling found that the public at large has much less confidence in the value of a college education than we did even as recently as 2015, despite evidence clearly showing that people with degrees earn significantly more during their lifetimes.

We at the College Fund have also been noticing anecdotal examples to suggest that the Covid pandemic, beginning in Spring 2020, really knocked our students – and their families, schools and supporting institutions – for a huge loop. Virtually every applicant we interviewed this summer offered unprompted examples of how Covid turned their high school and college experiences inside out. Isolating at home, empty Zoom classes, lost jobs, their stories run the gamut. Many of them are still trying to recover. In turn, colleges have been bending over backwards trying to find new ways to help their students get back on track.

Sometimes when groups ask us to come and give an overview of the Pinellas College Fund, it is fun to point out that we have helped send students to Yale, Stanford, Michigan and so many other well-known universities. But the recurring name that most warms my heart is St. Petersburg College. It is not our goal to steer students to any one place, but it seems clear that precious dollars can be stretched to the max when spent closer to home. That is especially true for students who are often the first in their families to attend college at all, and many of them must work while in school to help keep households together. Students have used SPC for decades as their first step toward their college degrees, which they ultimately obtain locally, at SPC, or far from here. We salute the powerful educational and economic engine that is SPC, currently celebrating nearly 100 years of serving the Tampa Bay area.

#### **Our Mission**

The College Fund of Pinellas County is a non-profit, tax-exempt organization run entirely by volunteers. Money is raised to help financially disadvantaged Pinellas County residents who have excellent scholastic potential, but insufficient funds to obtain a bachelor's degree and thereby improve themselves, their family's living standard, and their role in the community.

The College Fund has no paid employees. The financial contributions from its Directors and Advisors exceed its administrative costs; therefore, 100% of the donations from the public are used to support students. Since 1965 the College Fund has awarded over 1.4 million dollars in scholarships to over 870 Pinellas County residents.

## Hardships Faced by our Students

Sixty-seven students applied for scholarships, forty-two were considered, thirty-three interviewed and thirty were given scholarships. What we heard were stories of adversities through their lives, and yet they persevered and are now getting a college education. Many of the students live in single parent households on income because of limited divorce. abandonment, or death of a parent. Some assist with family members who are suffering from mental illness or disabilities. Others have endured severe abuse or have been victims of crimes. We noted an unusual number of the students are majoring in Psychology to learn how to cope with the concerns they are facing and their desire to help others who face the same issues. Some of the students live in transitional housing due to severe family conditions which included physical or substance abuse.

The past years have been unusual in the lives of these students due to the pandemic. They have had to adjust to a new environment, and we were amazed at their resiliency and strong desire to get an education. They told us how they have delt with challenges, and many expressed that they turned to their faith or to their teachers for guidance. Your donations are making an incredible difference for these students as they continue to work toward meeting their goal of a bachelor's degree.

#### **A Significant Donation**

We opened our mail earlier this year to learn that a retired Pinellas Park dentist had included us in his extensive list of bequests found in his trust agreement. His Tampa attorneys were checking with us to make sure that we would be willing to accept the \$13,600 he had designated for us. In College Fund Math, \$13,600 works out to more than 11 full-year scholarships for our students. Wow! You bet, we replied, and the check from the estate and trust of Dr. Keith E. Korneisel soon came our way. For us, manna from heaven, pure and simple.

We were not aware that Dr. Korneisel even knew of our work to help talented students get to college. Nor did any of our current board members or our supporters know of Dr. Korneisel. But we were so honored that he saw the enduring good of our work and decided to include us with nine other institutions like the University of Iowa College of Dentistry, Hospice of the Florida Suncoast, and the Science Center of Pinellas County. Chances are we will never know how Dr. Korneisel knew of us or why he decided to include us in his plans, but we feel he made an excellent choice if his goal was to help provide for the betterment of his home community.

Although we couldn't have foreseen his generosity, we still had plenty of good and effective ways to put his gift to work. After much discussion, our board of directors decided to put Dr. Korneisel's bequest to work in our Endowment Fund. Since he clearly had made long-range plans for us--he placed us in his trust eight years ago—we thought it a beautiful fit to grow his gift so that future Pinellas college students would enjoy his vision. In this way, he lives on forever through his giving. What do you think? Notice that Dr. Korneisel shared his estate with ten local and national non-profits; he didn't pick just one "winner" to the detriment of his other causes. He shared it with all of them, even as he included his extended family.

# Presentations

Two presentations were made on behalf of the College Fund during the summer months. **Palm Harbor Cares** and **100 Women Who Care-Pinellas** selected us to introduce/describe our charity in hopes of being awarded their quarterly grants. Both groups function similarly: three groups are selected and have five minutes to present plus five minutes for Q and A. The members then vote with one group receiving the funds.

Board member Bette Ra Ivey attended the July meeting of Palm Harbor Cares with President Dave Rogers who presented. The Lighthouse for Visually Impaired and Vincent House were also represented. Vincent House (job and social skills program for those dealing with mental illness) was awarded the grant.

100 Women Who Care met in August where board member, Lynda Lippman-Lockhart supported vice-president Sandy Campbell in her presentation. The other two groups who introduced their non-profits were Florida Dream Center and the winner, Ruth's Promise Day Care for Adults which provides programs for older adults and respite for caregivers.

Non-Profits are allowed to re-apply to these groups every quarter unless they are awarded the grant. We will apply again and to a third similar group, 100 Women who Care-St. Petersburg, for their fall meetings.

There was tremendous value in making presentations to two large charitable groups. Many more people are now familiar with the College Fund and our work. Several individuals made a point reaching out about their interest in supporting us and contacting potential student groups.
